### DECISION

### Statement of Reasons

On 22 March 2021, legal entity LIFE PHARMA DOO from Belgrade (4 Beogradskog Bataljona Street) submitted to the Ministry of Health of Serbia the Application for registration in the Register of Legal Entities that Perform Wholesale Trade, Import and Export of Psychoactive Controlled Substances.

Along with the Application, the following proofs were also submitted:

- Decision/Excerpt on the Registration of Business Entity (Serbian Business Registers Agency, ID/registration number: 21197858);
- Marketing Authorization for the wholesale of medicines, Ministry of Health, number: 515-04-8282/2019-11 dated 4 December 2019;

- Employment Contract for permanent employment with full working time for Jasmina Mikić, BSc in Pharmacy (number: 9116/1 December 2016, LIFE PHARMA DOO);
- Declaration of the Director that the above mentioned appended proofs are true copies of the original documents.

Acting upon the submitted Application and based on an insight into the appended proofs, it has been decided as stated in Items I and II of the operative part of this Decision.

This Decision is final in the administrative procedure.

Against this Decision, an administrative dispute may be instituted before the competent court for the settlement of administrative disputes, within 30 days from the Decision receipt date.
